

# What's New TextMap 2 - DRAFT

## 1. Introduction

- TextMap 2 is an important new version of our award-winning transcript summary utility. As we developed TextMap 2, our goal was to add significant enhancements while maintaining TextMap's vaunted ease of use. We hope you'll feel we've succeeded on both counts. We also hope you'll be pleased that at \$199 per user license, TextMap 2 remains a small fraction of the cost of competing transcript management solutions.
- Here are the important new features in TextMap 2:

## 2. Enhanced Transcript Importing

- TextMap 2 offers dramatically enhanced importing of electronic transcripts. TextMap 1 imported transcripts that were 25 lines per page and didn't have headers or footers. TextMap 2 imports electronic transcripts with any number of lines per page and with or without headers and footers.

## 3. Sophisticated Yet Easy-To-Use Cross-Transcript Searching

- TextMap 2 features new cross-transcript searching that lets you instantly locate and view all references to a word or phrase across all case transcripts.
- When electronic transcripts are imported into TextMap 2, each transcript word (other than common words such as "and," "but," "or") are indexed to and added to a Word List that appears by default in the Word Search task pane on the right side of the TextMap 2 window.
- As you type any word in the Search box at the top of the Word Search list, the words appearing are reduced to those that begin with the letters you've typed. Next to each word is a count of the number of times it appears across all transcripts and under the word listing is a list of the specific pages and lines where the word appears.
- When you float your mouse pointer over any listed hit, a hint appears showing the word in context within the transcript. When you click a listed word hit, the transcript containing it is opened and the word displayed in context.
- In addition to instant word searching, TextMap 2 offers advanced searching options that let you search for exact phrases, transcripts containing all words you specify, without words etc.

## 4. Built-in PDFing

- TextMap 2 features built-in PDFing like that in CaseMap 5. Rather than just print reports, PDF them without need for a full Acrobat license. There's even a Print to PDF and Email option that not only creates a PDF but also attaches it to a email ready to send.

## 5. Condensed Transcript Printing

- Two clicks in TextMap 2 and any transcript can be printed or PDFed as either full-sized pages or as condensed with four transcript pages to a printed page.
- Click to see a sample condensed transcript PDF created directly from TextMap 2. Please note that the first page of the transcript is printed at full size to provide a cover. Condensed printing begins on page 2.

## 6. Instant Search Results Reporting

- Want a report of your search results? In TextMap 2, it takes just two clicks to print or PDF a Search Result report. The word hits are printed from any or all transcripts and text above and below the line containing the hit is included to provide context. When senior partner X wants a list of

### 7. Transcript Highlight Reporting

- A critical component of TextMap is highlighting key testimony from transcripts and organizing it in CaseMap. TextMap 2 includes a new highlight report that prints the transcript segments in the order in which they appeared within the source transcript. or PDF a report showing the text that was used to send to CaseMap to create a fact as well as fields from the associated fact in CaseMap. Highlights are listed in the order in which they appear in the transcript providing a way to summarize the transcript. You control which CaseMap fields appear in the report.

### 8. Replication & Synchronization

- TextMap 2 includes new synchronization fetures that make it easy to take a TextMap transcript database with you as you travel or to send one to others on the trial team working at another organization.
- You can now take a copy of a TextMap file with you as you travel, add new transcripts to it, and highlight new passages that can be melded back into the master TextMap file when you return.

### 9. "Send-to-CaseMap" Functionality

- A key feature of TextMap remains the ability to cull critical facts from the transcripts and send them to a CaseMap file. The Send to CaseMap implementation in TextMap allows you to cull out passages and create new facts in CaseMap. You can also append new sources to existing facts.

### 10. Other New Features

- TextMap 2 offers customizable toolbars, customizable keyboard shortcuts and numerous other new features.
