TimeMap 4 makes it even easier to create polished timeline graphs.

Your timelines can be graced by a title page. They can also include introductions that provides additional textual background on events depicted in the timeline graph that follows.

Graphics such as organization logos can be included as headers and footers. Introductions can be any number of pages.

If you enable a title and/or introduction pages for a timeline, they appear in printed versions of the timeline, in the PDFs you can create using TimeMap 4's built-in PDF Writer, and in the PowerPoint slide shows created when you employ TimeMap 4's powerful new "Send to PowerPoint" feature.
